Game Rules & Instructions

Interactive Promotions Group Game Rules and Instructions completing a participating sponsor's official rules and regulations. By accessing this Web Site (the Site) it is deemed that tacit agreement has been made all persons viewing such site to have received and read the Official Rules and Regulations for a specific promotion or contest initiated by the Sponsor which disclosed this Site URL (web address) for the purposes of all Terms and Conditions attendant to such Rule and Regulations. To provide fair and equal chance of winning to all eligible persons, this promotion is intended for viewing and participation in The United States only. All Federal, State, Local, and Municipal Laws and Regulations apply. Please do NOT proceed if you are not a legal resident of the United States. VOID in Puerto Rico and where prohibited or restricted by law. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. PROMOTIONAL PERIOD: The promotion period starts and ends on the date and time as established by the Sponsor's Rules and Regulations, or until the number of Game Plays is met; whichever occurs first. This promotion is sponsored solely by such Sponsor and all time periods are subject to the Rules and Regulations.

2. HOW TO PARTICIPATE & PLAY: The Sponsor establishes the total of Game Plays which will be available. The Internet connection to the game site shall be connected solely to a computer under the control and custody of the Sponsor. Plays by a Player can only be made by accessing such computer, and usage is monitored by Sponsor and/or its employees. Additionally, all plays will be monitored by Interactive from a remote location. 3. ODDS & PRIZES: At the initial stage of the Game the number of prizes as well as the value of such prize(s) that can be won are determined only by the Sponsor and are referenced in that Sponsor's Official Rules and Regulations. DISPUTING A PRIZE: In the event of a dispute about a prize, a number of factors will be considered in order to establish the Winner's eligibility; (a.) the play receipt and all relevant play data in our database will used to validate the eligibility of the claim, (b.) conference of the Game Judges in order to collate the predetermined winning game number with the game play data that the Winner is bestowing or has developed. Finally the Game Judges' analysis will be the only basis that will decide the Winner's right to any prize. 12. Sponsor and the other Releasees are not accountable for any problems that may arise out of the use of, including but not limited to technical malfunctions of telephone network or lines computer online systems, servers or providers, computer equipment or software, viruses, bugs, failure of personal computers and/or software and hardware configurations, or failure of any email to be received by Sponsor or a participant for any reason including but not limited to traffic congestion on the Internet or at any website or combination thereof. Any damage to a user's system as a result of playing this Game or downloading any information necessary to participate in this Game cannot be blamed on the Sponsor

sor and the other Releasees.

DISCLOSURES:

13. Anyone who makes fraudulent claims, tries to intentionally sabotage any website, or disturb the operation of this promotion is breaking criminal and civil laws. If this happens, Sponsor and Interactive Promotions Group have the right to obtain corrective measures and damages from any such individual, as allowed by law, including criminal prosecution. The Sponsor and Interactive Promotions Group agree that if a debate results from this agreement or its contravention, and if the debate cannot be settled through direct discussion, such dispute shall be resolved by submission to the American Arbitration Association r:AAA·) or other arbitration services as agreed to by the parties pursuant to AAA rules and Tex. Civ. Prac. & Rem. Code 171.001 et seq. The award resulting from arbitration shall be binding on all parties to this matter. Any arbitration under this convention shall occur in Ardmore, Pennsylvania. Either party's rights to judicial action on any matter subject to arbitration hereunder is hereby waived, except suit to compel arbitration and / or to enforce the arbitration award which must be brought exclusively in the state district court of Delaware County, Pennsylvania, which the parties agree shall have personal jurisdiction over both of them. The prevailing party in arbitration in which an award is rendered is entitled to recover a reasonable attorney's fee to be established only on the amount of time spent by counsel. Any debate caused by this agreement or its violation will be solved by and adduce in accordance with the laws of the State of Pennsylvania without giving affect to such state rules concerning conflict of laws.
